



I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Kharam Vaiphei Kangpokpi District.

That on the 04 May 2023 at 1:00 Pm my above said residence (Owned/Rented) was attacked, destroyed and looted and burned by a group of Meetei/Meiteis radicals.

These criminals broke/open my gates(s), destroyed and looted every valuable property from my residence and premises worth Rupees 1,865,000 (Approx.) and they burnt down all the remainings.

While carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of Law.
