

Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of Kangchup Geljang Kangpokpi District.

That on the 4 May 2023 at 6 :00 Am/Pm my above said residence (Owned/Rented) was attacked, destroyed and looted and burned by a group of Meetei/Meiteis radicals.

These criminals broke/open my gates(s) destroyed and looted every valuable property from my "Owned/Rental" House, and premises worth Rupees 15 lakhs (Approx) and they burnt down all the remaining things.

That while carrying out their above said criminal activities, the said Meitei radical groups were shouting anti-tribal slogans like – "HAO HATLO", "KUKI HATLO", "KANGLEIPAK YAIPHARE", etc. Hence, the same can be taken as an insult on me and my family for being a tribal.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero FIR under relevant sections of the statutes of our country.
