

Sir,

With due respect, I have the honour to state that, in the intervening night of 3<sup>rd</sup> May, 2023 and 4<sup>th</sup> May, 2023, a large numbers of Kuki rioters including kuki militants holding sophisticated weapons caused some destruction of my house located at Charhajare. As such I along with my whole family members escape from my house due to fear and safety of our life. Regarding the matter, a complaint report had been made by my son namely Hemchandra Thoudam, aged about 30 years S/O (L) Amuyaiba Thoubam of Charhajare address to OC Sekmai Police Station on 12<sup>th</sup> May, 2023 and register a Zero FIR No. 00(5)2023 SEK-PS and same has been transfer to Gamnom Sapermeina Police Station.

Later on, it comes to light that, as information given by my neighbour of Charhajare stating that my pucca house was burnt down on 22<sup>nd</sup> May, 2023 by unknown persons suspected to be Kuki rioters & kuki armed militants. As a result of which, my house completely dismantled. The approximate value of the property that were burnt down is estimated about 45,50,000/- (Rupees Forty Five Lakh Fifty Thousand) approximately.

Regarding the matter, I couldn't able to report to the concerned police Station i.e. Gamnom Sapermeina Police Station due to present ethnic violence in the State as well as lack of legal knowledge.
