



With due respect, I have the honour to report that, I was running one local Tata truck bearing Regd. No. MN1-2254 which was driven by one Gambling (43) of Charbung village under the G-SPM police station. The said Tata truck was kept at the residence of the said driver after daily work. Due to on-going ethnic violence in the state. On 06/05/2023 at around 4:00 pm, my Tata truck was torched/ burnt down by suspected to be Kuki rioters and Kuki militants at Chahajar near NGYL ground. The approximate value of the said tata truck is Rs. 5,50,000/- (Rupees Five Lakhs and fifty thousand) only.

Regarding the matter, I couldn't report timely to the concern Police station i.e. G-Sapormeina PS due to the on-going ethnic violence. It is, therefore, requested kindly to take up necessary legal action.
