





Subject:- Report.

Sir,

With due respect, I have the honour to state that, I am running one rice hotel at Leimakhong Bazar since 5/6 years which is under the control of Kuki arms militants since the beginning of the current ethnic violence in the State i.e. starting from 3rd May, 2023. Due to threatening of life by unknown armed miscreants suspected to be Kuki militants, on 3/5/2023, I had escaped from my rice hotel for safety of my lives and couldn't return to my rice hotel till date due to present ethnic violence between two communities in the State.

However, on 12th September, 2023, it comes to light that some unknown person suspected to be Kuki armed militants had trespass my rice hotel in between 3rd May, 2023 to 11th September, 2023 and looted many properties i.e. one refrigerator, 2 gas cylinder, 1-bed, furniture item, utensil, kitchen items, cash(Rs 62,000/-) etc after breaking the back door of rice hotel. The approximate value of the vandalized & looted is estimated about Rs 2 Lakh(Rupees Two Lakh Approximately).

Regarding the matter, I couldn't able to report to the concerned police Station i.e. Gamnom Sapermeina Police Station due to present ethnic violence in the State.
