




Subject :- An application for requesting your good office to file FIR.

Frame No. MEA4JF91AGNG262744 & Engine No. JF9IE G 7263198. I could not inform your good office in time due to the prevailing ethnic clashes in Manipur and tracing the said vehicle.

Therefore, I earnestly request your good office to kindly take necessary action as per the land.
