

Sir,

I, the undersigned have the honour to submit that I and my family belongs to Sapormeina Village which is within the jurisdiction of Gamnom Saparmaina Police Station, PO- Motbung, Kangpokpi District. That on 3<sup>rd</sup> May, 2023 at around 11:30 pm, a large numbers of unknown persons belong to Kuki community backed by many armed personals suddenly attacked at our Village, Sapormaina, near forest beat in which my two wheeler Honda Activa 6G bearing No. MN01AM-6237 worth about Rs 97000/- (Ninety Seven Thousands) and all relevant documents of the said vehicle along with 2 keys was completely burnt down.

Therefore, all the villagers of the Meitei community were fled away and all our family members came towards Imphal. And at present my family is now taking shelter at Heingang Kontha Makha Leikai Model Club, Relief Camp, Imphal East, Manipur.


