Then threatened to kill all Meitei/Meetei inhabitants of the said village. Therefore, all the villagers of the Meitei community were escaped towards Imphal. And at present my family is taking shelter at Heingang Kontha Makha Leikai Model Club, Relief Camp, Imphal East, Manipur.

I, therefore, request you to kindly take up necessary action by lodging FIR against the Kuki culprits at an early as possible.
