

Subject: Request for lodging of FIR case for destroying house and threatening our live.

Sir,

I, the undersigned have the honour to submit that I and my family belonged to Saparmeina Village which is within the jurisdiction of Gamnom Saparmaina Police Station. PO.- Motbung, Kangpokpi District,. In the midnight between 3<sup>rd</sup> and 4<sup>th</sup> May, 2023, a large numbers of Kuki community backed by many armed personals sophisticated weapons suddenly attacked at our houses thereby my house and properties worth about Rs 300000/- (Three lakhs) has been completely damaged and looted all properties. Then threatened to kill all Meitei/Meetei inhabitants of the said village. Therefore, all the villagers of the Meitei community were escaped towards Imphal. And at present my family is taking shelter at Heingang Kontha Makha Leikai Model Club, Relief Camp, Imphal East, Manipur.

I, therefore, request you to kindly take up necessary action by lodging FIR against the Kuki culprits at an early as possible.
