

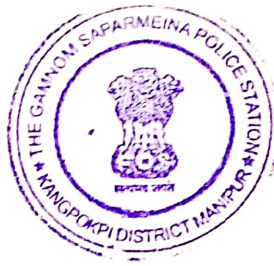

**Subject: Complaint/Report on the attempt to murder / crimes of unlawful displacement,
Looting, vandalism, arson attack and discrimination of Schedule Tribes.**

Respected Sir,

With reference to the above cited subject. I have the honour to report to you as follows:

That, I am a Schedule Tribe belonging to the Vaiphei Tribe, which is a recognized Tribe under the Constitution of India. And, I am a permanent resident of Z. Lhangzawl Village, P.O – **Lamsang, P.S G.SPM-PS, District – Kangpokpi, Manipur.**

That, on the **8th of May, 2023**, at about **1:30 AM**, a huge contingent of armed radical Meitei/Meeteis suspected to be members of the Arambai Tenggol and Meitei Leepun attacked our village and, in the process, they have looted, vandalized and torched my house

That, we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings which is estimated to be about **Rs. 2,10,000/- (Rupees Two Lakhs Ten Thousand) Only.**

That, as a victim who suffered the hatred and raged of the Meitei/Meeteis, and the reason behind the late filing is that, we were hiding in different places, including forests and exextra, we were also in Kangpokpi town for days, therefore, I humbly pray you to kindly register a **Zero FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing this report lately today.
