



With due respect, I have the honour to state a few lines for your kind consideration and further necessary action that, on 24/10/2023 at about 04:30 am to 07:00 am search operation was conducted at L.Champhai village, Leimakhong by a combine team of Superintendent of Police Kangpokpi, Additional Superintendent of Police (L/O) Kangpokpi, alongwith 2-platoons of D167 CRPF, 1-platoon of B20 CRPF and IS column of Indian Army (20 JAT) during cardon and search operation in L. Champhai village area, in the jungle, which is about 100 meters west of L. Champhai Church, inside the jungle in that location a freshly dug and covered surface was noticed which was found suspicious, when unearthed, the following items were found hidden beneath the ground wrapped by gunny bags.

**Particulars of the recovered items:**


1. 1 nos of SLR with Magazine bearing Regtd. No. 15373609
