

With due respect, I have the honour to state a few lines for your kind consideration and further necessary action that, on 04/09/2023 at 6:30 pm a combine teams of Leimakhong Police Station and IS column of Indian Army (20 JAT) carried out foot patrolling duty in and around the jurisdiction of Leimakhong Police Station and recovered electric wire weighing of more than 50 kilograms near Electricity Power house, Leimakhong (Ref. to GD. No. 05/LMK-PS/2023 dated 04-09-2023) and the next day the same team carried out foot patrolling duty and recovered electric wire weighing of 200 Kilograms approximately at N.C Phai village (Ref. to GD.No. 05/LMK-PS/2023 dated 05-09-2023).

The recovered items are suspected to be belonging to the Electricity department property Government of Manipur which are trying to be stolen by unknown miscreants and the said items have been kept in safe custody of Leimakhong Police Station.

The matter could not be reported timely due to the prevailing Law and Order situation in the state, It is therefore requested to kindly take up necessary legal actions.
