





Sir,

I have the honour to report that I am running two shop namely (Samsung Boyz Mobile Home Appliances and Vivo Boyz Mobile nand 2 godown) at Leimakhong bazar which is under the control of arm militants since the beginning of the present ethnic violence in the state i.e. since 03/05/2023. Accordingly, on 4/5/2023 my shops and godowns has been closed under proper lock and key due to fear and safety of my life. However, many valuable goods items/ properties were looted from my shops and godowns accepts Samsung Boyz Mobile Home Appliances. Accordingly a cases has been register at Sekmai Police Station under Zero FIR No. 00(130)(5)2023 Sek-PS u/s 397/400/435/436/427 IPC & 25(1-C) A. Act and Zero FIR No. 00(131)(5)2023 Sek-PS u/s. 397/400/435/436/427 IPC & 25(1-C) A. Act respectively. However, on the intervening night of 25/09/2023 and 26/09/2023, some unknown persons suspected to Kuki militants holding sophisticated weapons have come and trespass my Samsung Boyz Mobile shops and looted and undernoted valuable properties from my shop after breaking the shutter.

The Properties that were looted are as follows:

1. Refrigerator – 10 x20,000 = Rs 2,00,000/-
2. Washing machine – 10x18000 = Rs. 1,80,000/-
3. TV Samsung 32 inch – 10x 15000 = Rs. 1,50,000/-
4. TV Samsung 32 inch smart – 15x 20000 = Rs. 3,00,000/-
5. TV Samsung 43 inch – 20x 35,000 = Rs. 7,00,000/-
6. TV Samsung 43 inch HUB – 20x 45,000 = Rs.9,00,000/-
7. TV Samsung 50 inch – 15x 50,000 = Rs. 7,50,000/-
8. TV Samsung 55 inch – 20x 60,000 = Rs. 12,00,000/-
9. TV Mebiatek 32 inch – 10x 10,000/- = Rs. 1,00,000/-
10. TV Mebiatek 40 inch – 10x 20,000/- = Rs. 2,00,000/-
11. TV Mebiatek 43 inch – 10x 25,000/- = Rs. 2,50,000/-
12. TV Mebiatek 50 inch – 4 x 35,000/- = Rs. 1,40,000/-

Total approximate value is about Rs. 50,70,000/- Approximately

Regarding the matters I couldn't able to report to the concern police station i.e Gamnom Sapormeina PS till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
