





I have the honour to report that I am running one shop namely (Rose Tailor) at Leimakhong bazar which is under the control of arm militants since the beginning of the present ethnic violence in the state i.e. Since 03/05/2023. On the intervening night on 2/5/2023 my shops has been closed under proper lock and key due to the fear and safety of my life. However, its Comes to light that 14/10/2023 at 5:00 pm many valuable goods items i.e tailoring machine, Clothes for stitching (like Satkar premium, Regency (Sargam) Siyaram white shirt, Sugam Suiting Orchid Suiting, Army(Nahar), and Evergreen shirting), (cash Rs. 1,50,000) and other properties were trespass and vandalized/looted from my shop by some unknown persons suspected to be Kuki militants and kuki rioters holding sophisticated weapons after breaking the shutter. Total approximate value is about Rs. 25,00,000/- (Rupees twenty five lakh) Approximately.

Regarding the matters I couldn't able to report to the concern Police station i.e. Gamnon Sapormeina PS till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to look into the matter and take up necessary action at the earliest.
