

With due respect, I have the honour to report the following firing incident for your kind immediate action.

That, today early morning i.e. 14/11/2023 at around 1:00 am, a group of unknown Meitei armed miscreants fired several rounds using sophisticated weapons upon my village from the house compound of one Ram Kumar Poudel(73) H/O Maya Devi of K.Lhangnom Village resulting to damaged of properties and creating nuisance and fear to the innocent civilians and villagers within the surroundings. However fortunately no casualties was found.

In this regard, I requested you to kindly take up necessary legal action against those persons involved in commission of the Crime.
