





Today, i.e. 15/11/2023 at 4:30 pm received a reliable information from own source that on the same day at around 4:10 pm one Tata Truck bearing Regn No.AS01PC- 9144 driven by unknown coming from Imphal side towards Dimapur dashed one Bolero B/Regn. No. MN06LB -5312 driven by unknown coming from the opposite direction at between G.Kholep & Monpijang Village near a Culvert along NH-2 due to rash and negligence on part of the Tata Truck Driver resulting to dead of one occupant of the said Bolero namely Amangliu Panmei (44) w/o Z Asong of Namlalong Ward No II, Tamenglong and injury of three other occupants of the Bolero and causing damaged of the bolero. The three injured persons were immediately evacuated at Raj Medicity, Imphal for medical treatment.

Hence a suo-motto case has been registered under FIR NO. 691(11)2023 G-SPM-PS U/S 279/338/427/304-A IPC for investigation.
