





I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident  
Of Nakhujang Village Kangpokpi.

That, on the 2-6,2023 at 4PM my above said residence "Owned/Rented" was attacked, destroyed, looted  
and burned by a Group of Meitei/Meiteis radicals.

These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence  
and premises worth Rupees 1,47,000 (Approx.) and they burnt down all the remainings.

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal  
slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an FIR/Zero  
FIR under relevant sections of Law.
