




Sir,

With due respect I have the honour to state that today i.e 20/11/2023 at around 9:30 am, two individuals namely (L) Thangminlun Hangshing (26) S/O Lunkhongam Hangshing of Khunkho Kuki, Kangpokpi District, Manipur and (L) Henminlen Vaiphei (38) S/O Luntinlal Vaiphei of L.Phaijang Village, A/P Leimakhong Mission Veng, Kangpokpi District, Manipur were shot dead in the deserted forest between Leilon Vaiphei Village and Kharam Vaiphei village by unknown armed miscreants suspected to be from Meitei community.

I, therefore request you to kindly take up necessary legal action in this regard to cause arrest of miscreant involved in committing the crime.
