Whereby, I am a permanent resident of Kangchup Chingkhong Phailenjang Veng P.S Lamsang District Kangpokpi
- 2.That, on 7th May2023 at 10 AM/PM, a huge contingent of armed Radical Meeitei/Meitei Mobs, Arambai Tengol and Meeitei Leepun along with State Forces like Manipur Police Commando and Indian Reserve Battalion (IRB) attacked our village, and in the process looted/vandalized/burnt my house/properties.
- 3.That, the above said Criminals with their inhumane activities have grave caused me grave mental agony. Not withstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs 1Crore,40 Lacs
- 4. Fortunately, me and my family narrowly escaped from these Criminals who even tried to kill us. Hence forth, we are taking refuge at Khominthang, Churachanpur
