Sir,

- 1. Internal Security Duty columns of Assam Rifles were deployed in the general area of L Munlai Village under Leimakhong PS KPI Dist for protection of civilians and maintaining peace as per requisition made by the Govt of Manipur.
- 2. On 21 Jun 2023 at approx 1745 hours indiscriminate automatic weapons fire took place between Manipur Cdo/ Police and suspected miscreants at General area L. Munlai village under Leimakhong PS KPI Dist. One column of Assam Rifles was launched to control the volatile situation. The column carried out enhanced area domination. During the fire fight, automatic weapons were fired on the column. Assam Rifles troops responded in a calibrated manner with controlled fire. in self-defense and for protection of civilians in the area. No casualties were reported by locals / forces during the said incidents.
- 3. You are requested to kindly file an FIR against unknown armed miscreants and investigate the incident for attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorised usage of fire arms and ammunition to include automatic weapons.
