Subject: FILING OF FIR AGAINST ARMED RIOTERS

Sir,

1. Internal Security Duty columns of Assam Rifles were deployed in the general area of K. Tukun village for protection of civilians and maintaining peace as per the requisition made by the Govt. of Manipur.
2. On 02 Jun 2023 at approx. 0930 hours two unidentified individuals from K. Tukun village under Kangchup PS KPI dist. Se fire to foliage near Apoulak River resort. Two rounds of unaided were heard from K. Chingkhong village. The firing continued from both sides till 1130 hours and started again at 1430 hours including Lathod and Mor fire between village volunteers of K. Songlung village and teams of Manipur CDOs.
3. A column of Assam Rifles co-ordinated with SP Imphal West and launched multiple small teams to control the situation and managed to push back volunteers from Tukun village thereby creating a buffer zone between the fire fight. Assam Rifles troops responded in a calibrated manner with controlled fire, in self-defense and for protection of civilians in the area. No casualties were reported by locals/forces during the said incidents.
4. You are requested to kindly file and FIR against unknown armed miscreants and investigate the incident for attempt to murder with deadly weapons, to deter public servants suppressing riots, causing hurt with dangerous weapons and unlawful carriage of dangerous weapons and unauthorised usage of firearms and ammunition to include automatic weapons.
