Subject:- Report on the homicide of my daughter namely Lamminchong Kipgen by suspected Meitei miscreants on the 4<sup>th</sup> of May 2023.


Sir,

With due respect, I the undersigned would like to bring to your kind attention regarding the alleged murder of my daughter Lamminchong Kipgen (24) of Kangchup Patbung Village, Kangpokpi District.

That, on 4<sup>th</sup> May 2023 at around 9:30 am, a group of Meitei miscreants suspected to be a member of the Arambai Tengol, Meitei Leepun and local youths from neighbouring villages who were armed with sophisticated weapons attacked our villages and started burning down the houses in our villages. On seeing them, I along with my family run towards the nearby forest to save our lives including my daughter Miss Lamminchong Kipgen. While we were running towards K.Songlung Village later, my daughter namely Lamneichong Kipgen was shot on her back and later succumbed to her bullet injury. Then the local nearby villagers help us to get away from the spot and on the same day at around 1:00 pm her lifeless body was buried at the village cemetery.

Due to the prevailing law and order situation and mourning about the death of my daughter, I could not report the matter timely. In this regard, I request your goodself to kindly take up necessary legal action against the culprits to bring justice as per law of the land.
