



Sir,

With due respect, I have the honour to state that on the 29 June 2023 at around 4:50pm unknown miscreant numbering more than 200 people from the Meitei community suspected to be members of Arambai Tengol, Meitei Lepum, extremist volunteer holding deadly weapons including Automatic Rifles attack our village K. Bethel, Kangchup Geljang sub-Division, Kangpokpi District. They robbed, demolished and burnt down my house along with the following properties and important documents etc.

The details are as under:

1. House building (Semi pucca)	- Rs:8,00,000/-
2. Household items I/e furniture & others	- Rs:5,00,000/-
3. Electronic items	- Rs:2,35,000/-
4. Live stock I/C granaries	- Rs:1,35,000/-
Total Rs:1,615,000/-	

The total amount of destroyed properties are estimated at Rs. 1,615,000/- (Rupees sixteen lakh fifteen thousand only).

The incidents could not be reported immediately due to insecurity of our lives and volatile situation of the area.

I therefore request you to kindly take up necessary action against the miscreants involved in the commission of the crime.
