

I the undersigned have the honour to report on dated 4th May 2023, at around 11:00 am a group of unknown miscreant from Meitei community, suspected to be member of Arambai Tenggol, KKL and Meitei Leepun numbering more than 1000 people holding deadly and sophisticated weapons attacked my residence at Kanchup Patjang. I along with my family had escaped and the miscreants then looted and burnt down my properties including documents and household uses. The total amount of properties looted and burn down by the miscreant's amount to Rs. 50, 00,000/- (Fifty Lakhs) only.

Therefore, I request to lodge an FIR in connection with this incident and to take appropriate action against the miscreants at the earliest.


