Sir,

I, the undersigned have the honour to state for the following a few lines for your kind consideration necessary action.

That, I L. Kiran Singh (35 yrs.), S/O. (L) L Sachi Singh a resident of Torbung Bangala village situated under the Phougachao Ikhai Police Station, Bishnupur District. Due to the ongoing communal conflict erupted on 3rd May, 2023 between Kuki and Meitei communities, entire village i.e. Torbung Bangala village have blazed, including my houses and livestock, lost around an amount of Rs. 21,51,000/- (rupees twenty one lakhs fifty one thousand) only. On 3rd May at around 6.00 pm the reason, nowhere to take refuge shelter in our village. So, we fled for saving our life, our whole family is now taking shelter at our Grandfather resident at Kwasiphai Village, P.O. & P.S. Bishnupur.

In this regard, I am submitting damaged report for Properties for your kind information. Delay of FIR lodge is due to the displace and lack of knowledge.

I do hope you might be taken an action for receiving compensation of the said matter on humanitarian ground.
