Sir,

With reference to the above cited Subject, I have the honor to report to you as below:

- 1. That, I Seikholet Kipgen, Aged 64 H/O (L) Heneng belongs to KUKI Community, a Schedule Tribe recognized under the Constitution of India, by which I am entitled for protection under the ST/SC (Prevention of Atrocities) Act,1989. Whereby, I am permanent resident of Singda Kuki, Kangpokpi, Gamnom Sapormeina.
- 2. That, on 5th May 2023 at 6am, huge contingent of Armed Radical Meitei/Meiteis, ArambaiTenggol and Meitei Leepun attack our house and in the process looted/vandalized and burnt our house and properties.
- 3. That the above said Criminals with their in humane activities have caused me grave mental agony. Notwithstanding the fact that, their unruly activities have made me loss enormous wealth estimated to be Rs.10.5 Lakhs only.
- 4. Fortunately, me and my family narrowly escaped from these criminals who even tried to kill us. Henceforth, we are taking refuge at Kholmun Relief Camp Churachandpur.
- So, I could not make the said report on time due to present situation which unable me to do the report. I, therefore, request you to register on FIR and bring justice.
