



Unfortunately, it is also learnt from reliable sources that all my household properties were ransacked, plundered and looted by unknown miscreants believed to be volunteers of Arambai Tenggol and Meitei Leepun on the 6th of June 2023.

The estimated value of the properties lost, damaged or looted is about Rs. 60,00,000/- (Rupees Sixty Lakhs)


In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.
