

Subject:- An application for requesting your good office, to registered an FIR.

Sir,

I the undersigned on behalf of KangchupTwikun Villagers would like to report to your good office that hundreds of Meitei Mob (Meitei Militia) led by the Arambai Tenggol, Meitei Leepun assisted by the local people of Phayeng, Kangchup Kharang of Imphal West District were attacking our village i.e., Kangchup Twikun Village Kangpokpi District several times i.e., the 6th to 15th May, 3rd & 4th to 6th June, 9th -11th July & 2nd September of 2023 by using sophisticated weapons & bombs, shells etc. and the local people (Kangchup Twikun villagers) were running for our life and safety. The intruders had vandalised, looted & burnt down 6 Houses and several houses were hit by the bullets and bombs fired by above mentioned Meitei Militia. Moreover, they vandalised most of our houses looted several shops, destroyed furnitures & structures etc. And most of the important documents including student's documents were also burnt down or destroyed.

That due to frequent attack on our village by the above mentioned Meitei Militia on our village; it is not favourable for the innocent villagers especially for women, children and aged persons. Therefore we have left our village i.e., Kangchup Twikun hide in Kangchup Forest and face a lot of difficulties in the midst of the forest for shelter as there is scarcity of food and water with a lot of flies and mosquito. Later on after a long journey to Kangpokpi Town via Tamenglong District travelling on Shaktiman Truck on off road with a lot of difficulties and hardship. And women, children and aged persons have taken refuges at various safer places at Relief Camps at Kangpokpi & Churachandpur Districts. Till now our village is guarded by Village Volunteers Force comprised of Youths and middle aged men in the village.

Till now our village is guarded by Village Volunteers Force comprised of Youths and middle aged men in the village. Sometimes we (the Village Volunteers of the Village) have retaliated several times by using Licence 12 bore guns but the mighty sophisticated weapon used by Meitei militia doesnot match our weapons. Therefore, sometimes we left the village for our own safety.

The Kangchup Twikun Village is about 408 Populations & 83 Household as per the Hill House Tax paid to the concerned competent Authority.

The atrocity act of act of the above mentioned Meitei Militia is inhuman, ethnic cleansing and totally against our existence. Most of the aged persons in our village are still in fear psychosis and have mental traumatic problems.

Therefore, I earnestly request your good office to kindly take necessary action as per the law of the land. Which your act of kindness and necessary action therein, I shall remain grateful to you.


