That due to frequent attack on our village and its nearby villages of Kangchup Tribal Area by the above mentioned Meitei Militia on our village; it is not favourable for the innocent villagers especially for women, children and aged persons. Therefore we have left our village i.e., KangchupKhul Bangla and took refuges at various safer place at Relief Camps at Kangpokpi&Churachandpur Districts. Till now our village is guarded by Village Volunteers Force comprised of Youths and middle aged men in the village.

The KangchupKhul Bangla Village is about 160 Population &32 Household as per the Hill House Tax paid to the concerned competent Authority.

Therefore, I earnestly request your good office to kindly take necessary action as per the law of the land.

Which your act of kindness and necessary action therein, I shall remain grateful to you.
