

Sir,

I the undersigned on behalf of Songjang Waphong Villagers would like to report to your good office that on the fretful day i.e., the 6th May 2023 (Saturday) around 11:30 a.m hundreds of Meitei Mob (Meitei Militia) led by the Arambai Tenggol & Meitei Leepun assisted by the local people of Singda, Kadangband of Imphal West District were attacking our village i.e., Songjang Waphong Village Kangpokpi District by using sophisticated weapons & bombs, shells etc. and the local people (Songjang Waphong villagers) were running for our life and safety. The intruders had vandalised & looted our village and some of the important documents are also burnt down or destroyed.

That due to frequent attack on our village and its nearby villages of Kangchup Tribal Area by the above mentioned Meitei Militia on our village; it is not favourable for the innocent villagers especially for women, children and aged persons. Therefore we have left our village i.e., Songjang Waphong and took refuges at various safer place at Relief Camps at Kangpokpi & Churachandpur Districts. Till now our village is guarded by Village Volunteers Force comprised of Youths and middle aged men in the village.

The Songjang Waphong Village is about 140 Population & 32 Household as per the Hill House Tax paid to the concerned competent Authority.

Therefore, I earnestly request your good office to kindly take necessary action as per the law of the land.


Which your act of kindness and necessary action therein, I shall remain grateful to you.
