Sir,

That on 25<sup>th</sup> feb 2023 at about 8:30 AM my driver call me and state that on the early morning of 25<sup>th</sup> Feb 2023, some unknown miscreants torched 2(two) Excavator i) Model no.PC210-8MO, SI No. N721200 and ii) Model No. PC210-8MO Machine SL No. N720392 which was utilised for construction work and parked at the Quarry Site near Kharam Vaiphei Village, Kangpokpi District, belonging to Keystone Infra Pvt. Ltd, the contracting agency deployed for Rehabilitation and Structural Improvement of Singda Dam, Manipur, Under DRIP- II. The unknown miscreants have left one Yellow envelope written on it a warning note stating " **Do not try to Flash the news in the media or else we will take more serious action**" and one contact no. 9233129734 written on it, one live round ammunition wrapped in a piece of paper was also found inside the yellow envelope. It is suspected that the miscreants had given a clue so as to communicate with the workers of the company. Such disturbances by anti-social element had aroused fear psychosis among the migrant workers who are working for the project ultimately impeding the progress of Rehabilitation works over Singda Dam . It is totally regretted to learn occurrence of such activity within the state affecting the development works of the state funded by World Bank for the welfare of the state .

A requisition was also submitted to the Director General of Police , Manipur vide Ref. No. KSIPL/MN/WRD/SINGDA DAM/2022-23/19,Dated :- 25/02/2023 to provide security personnel in the work site.

In this regard, I request your goodself to take up legal necessary action and nap the culprit behind this unlawful activities.

Your immediate action in this regard will be highly appreciated.
