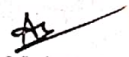


Today i.e. 02/02/2024 at 8:35 pm received a reliable information that on the same day at around 8:30 pm, one Hyundai Santro car bearing regd. No. MN06L-3770 driven by one unknown driver which was proceeding from Imphal side towards Nambol side collided with one motorcycle Royal hunter bearing regd. No. MN01AM-5731 ridden by one unknown rider which was crossing from Bamdiar IVR side at Kodompokpi Lamkhai along Tiddim road. The incident was happened while the motorcycle Royal hunter tried to cross the road from Bamdiar IVR towards Kodompokpi IVR due to rash and negligent driving on the part of the unknown driver of Santro car and the unknown rider of motorcycle. As a result of which, the rider of motorcycle received injury on his person and evacuated to hospital for medical treatment. Both the involved vehicles were also badly damaged.

Hence, a regular case under FIR No. 07(02)2024 NBL-PS U/S 279/338/427 IPC is registered on suo moto for investigation.
