

Subject: FIR against looting of household properties at my home at Kangchup Kotzim Village  
by unknown miscreants.

Sir,

With due respect, I would like to state the following for your kind information and necessary action :-

That, due to the on-going conflict, we were compelled to flee our home located at my land at Kangchup Kotzim Village, PO Lamsang, PS Gamnom Sapormeina, Saitu Gamphazol Sub-Division, Kangpokpi District, Manipur, on the 4<sup>th</sup> of May, 2023 around 2 PM.

Unfortunately, it is also learnt from reliable sources that all my household properties were ransacked, plundered and looted by unknown miscreants suspected to belong to Arambai Tenggol, Meitei Leepun assisted by Meitei communities from the nearby localities.

The total cost of properties lost, including all household items, piggery farm and many other valuable properties is estimated to be about Rs. 50,00,000 (Rupees Fifty Lakhs)

In this regard, I would like to request your good office to take up necessary action so that I can be compensated, the culprits be caught and stringent exemplary punishment be meted upon them.


