Subject : Request for lodging of FIR case for open firing and threatening our live.

Sir,

We, the undersigned have the honour to submit that we belonged to Saparmaina Village Meitei Youth Club which is within the jurisdiction of Gamnom Saparmaina Police Station, PO Motbung, Kangpokpi District. In the midnight between 3<sup>rd</sup> and 4<sup>th</sup> May, 2023, a large numbers of Kuki community backed by many armed personels suddenly attacked at our village, Saparmaina thereby Our Club house and properties worth about Rs. 1100000/- (Eleven lakh) has been completely damaged by igniting fire and many round of bullets were also fired. Then the said community threatened to kill all Meitei/Meetei inhabitants of the said village. Therefore, all the villagers of the Meitei community were fleeing away and we all coming towards Imphal. And at present my family is now taking shelter at Heingang Kontha Makha Leikai Model Club, Relief Camp, Imphal East, Manipur.

I, therefore, request you to kindly take up necessary action by lodging FIR against the Kuki culprits at an early as possible.
