

Sir,


I have the honour to report that, today i.e. 30/12/2023 at around 3:30 am received a report from a reliable source that a heavy exchange of fire took place between village volunteers of both from Meitei and Kuki community in between hill ranges of Nakhujang and Singda Kuki Villages and lasted till 4:20 am the same day in which one Meitei volunteer later identified as one Ningombam James @ Nanao Singh(32) S/O N.Rameshor Singh of Mayang Langjing Taning Mayai Leikai sustained bullet injuries and evacuated to JNIMS Hospital, Porompāt and later succumbed to his injuries.

In this regard, I request your esteem office to take up legal necessary action.
