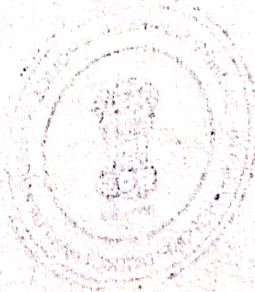

Sub : Report

Sir,

On Date 03/05/2023 at around 8.00 PM unknown persons numbering around 300 burnt down my house located at Motbung Bazar which is utilized as a business centre by three persons. My house is a double storied utilized as business centres by three occupants on monthly rental basis. The ground floor is a long un-partitioned space with three large shops in the first floor. The unpartitioned hall in the ground floor is utilized as a godown by Mr. Ashok Gupta to stock items who is also utilizing the 2<sup>nd</sup> shop in the first floor as a grocery shop dealing in wholesale and retail sales. The total worth of my house along with the furnitures is Rs. 75 Lakhs.

The first shop in the first floor is utilized by Mr. Kaikhochon Lhouvum, S/o Mangkhopao Lhouvum of Motbung Village as a business centre in screen printing and distribution point for uniform of 2 in 1 Omega public school and Kindergarten, Motbung. In the inferno, the following properties were completely destroyed.

1. 4 colours screen printing machine – 1 No.
2. Air Compressor – 1 No.
3. Cup printing machine – 1 No. (along with cups of varied sizes)
4. Vinyl Cutter -1 No.
5. Vinyl paper of Blue, Black, white, Grey, green and Red – 2 Nos. each
6. Sublimation Printer-1 No. with Sublimation paper
7. Plastisol Inks
8. Sublimation ink and Subli Vinyl
9. School uniform shirt of white colour, Skirt (chequered black and grey), T-Shirts (Yellow, green, Red and Blue), Shoes (Black and white), Bags, Sweaters, Black Pants, Grey Pants. All uniforms are of assorted sizes for Pre Nursery to Cl. X. The total worth of School uniform items is approximately Rs. 10 lakhs.
10. Heat Press Machine – 1 No.

The total worth of school uniform items of 2 in 1 Omega Public School and Kindergarten and all the screen printing machines and screen printing accessories of Kaikhochon Lhouvum is worth approximately 25 Lakhs.

The second shop is occupied by Shri Ashok Gupta. He is utilizing the shop in running a grocery shop doing wholesale business and also retail sales. He also occupies the un-partitioned space in the basement/ground floor as a Godown for his grocery items. In the inferno, the grocery items in his shop (Rice, Dal, milk.... Etc) and the stock kept in his Godown in the ground floor was completely gutted. List of items gutted in the fire as under;

The approximate value of the properties burnt down is worth approximately 34 Lakhs and Thirty one thousand.

The third shop is occupied by Shri Raju Pokhrel. He is utilizing the shop in running a Pharmacy. In the inferno, all types of medicines and furniture, Furniture rack etc was completely gutted down. The list of items damaged are as under;
