


Subject:- Report.

Sir,

Today i.e. 2/3/2023 at around 3:30 pm received a reliable information from own source about a detention of one individual by Public at Lower Khengjang area. Acting on the information, Self, ASI Paolenlal Manlun alongwith Highway Patrol team of G.SPM-PS who were on mobile patrolling duty along NH-2 rushed to the said area. On enquiry, the team apprehended one individual near Motor Vehicle, Office located near Lower Khengjang who was later identified as Suraj Basnet(20) s/o Ran Bahadur Basnet of Gorkha Tapon, Irang Pt-II, Kangpokpi District, Manipur. He was found detained by the villagers due to stealing of Purse from one of the loaded trucks plying along NH-2 near MVI Office, located near Lower Khengjang. On preliminary questioning he revealed that he stole the purse containing Rs. 11,000/- (Eleven Thousand) from the loaded truck while the said truck was parked at near MVI Office, near Orphange along NH-2 on 27/2/2023 to buy drugs as he was a drug abuser. He was caught today by the villagers as they saw and recognised him from the day he stole the purse. On recovery of the stolen purse it was found that the said purse was owned by one tata truck driver B/Regn. No. NL01AB-8508 namely Umesh Rabha (30) s/o Duta Nath Rabha of Dasarapara Matiya, Balijana, Goalpara, Assam. The recovered Purse has been handed over to the owner but unfortunately the stolen cash could not be recovered as the above mentioned accused used it for purchasing drugs.

The apprehended individual has been handed over to you to take up necessary legal action against him.
