

I have the honour to report that ,on 03/05/2023 at around 6:00Pm, the large number of Kukis rioters with knives, sticks ,iron rods, weapons sharp objects etc.came to my rented house located at Motbung Meitei Leikai was burned down and also destroyed as well as looted much of my properties by the rioters.

The properties that were burn down and looted are as follows:

1. 6 Big size Sewing Machine & 1 small Sewing Machine- 78,700/-
2. 1 Refrigerator – Rs.18000/-
3. 3 Gas Cylinder- Rs.9000/-
4. Gas Frame – Rs.3000/-
5. Washing Machine- Rs. 18000/-
6. Store Materials – Rs.50000/-
7. Cloths Tailor – Rs.200000/-
8. T.V. – Rs. 1200/-
9. Gold – 12000/-
10. Cash – Rs.582000/-
11. House Materials – Rs.200000/-
12. 3 Induction – Rs.6000/-
13. 2Stand Fan- Rs.5000/-

Total approximate value is about Rs.13,08000/- approximately
