I am Mrs. Sapam Panchami Devi, W/o: Mr. Konthoujam Kuber Singh, Founder of Anji Leima Singja Khombi Institute, Estd. 2013, Regd. No. 456/B/SR-016; Inhabitant of Phougakchao Ikhai Mayai Leikai, Bishnupur District, Manipur State, have the honour to state the following few lines that - on 03/05/2023 at about 3:45 pm more than 550 Kuki Militants holding deadly weapons such as guns, daos, swords, sticks, etc came in war footing nature including fires arms, burns and destroys many Meitei houses in my Villages. Seeing all the bad situations sometime, I and my husband with my dearest two sons named -

- i) Konthoujam Chingkeingnaba, Admitted at D.M College of Sciences, 1st Sem. Sciences, Mathematics Honour & Staying now at D.M College Boys Hostel, Imphal Manipur.
- ii) Konthoujam Malemnganba (PwD), Admitted at BB Paul Mental School & Staying now at BB Paul Boys Hostel, Mongsangei, Imphal Manipur.

We were escaped from my village since 3rd May, Wednesday 2023 and stay some days at my relatives houses at -

- i) Keirenphabi Village
- ii) Relief Camp, Kumbi Terakhunou Primary School
- iii) Rented House, Naoremthong Khumanthem Leikai Lane - 5,
C/o. Tongbram Manihar Singh, Imphal West District, Manipur.

Moreover, the last nine months during 03/05/2023 to 12/01/2024 periods and till, the conflict was not end. And also, the unknown Kuki militants destroyed my house, gates, fences, school signboard and looted some of my properties.

In this regard, I pray you that, a case registred (FIR) must be filed and take a kind necessary action against the real culprits. For, this kind of your act, I shall remain a thankful to you forever.
