Subject: Attack by miscreant (apparently KUKI)to ex-servicemen at Leimakhong Market area.

Dear Sir,

- The undersigned had visited URC at Leimakhong Military Station on 19<sup>th</sup> May 2023 at around 0930hrs to make some purchases. On my way back from the URC, I was waylaid by some armed miscreants who tried to stop my car.
- 2. It is pertinent to mention that the undersigned is the first Adm Comdt of Leimakhong Mil Stn had been in touch with the village heads of the surrounding villages until I retired in Feb,2011.
- 3. The following details about the incident are submitted for your kind information and necessary action please:
  - a) At around 1145 hrs,I came out of Koubru Dwar on my way back from the URC.
  - b) When I had just crossed gate of ASC Coy, I saw three young boys in their early twenties standing at the western side of the road.
  - c) Complete stretch of road from Koubru Dwar to the turning near station HQ complex was deserted except for the presence of those three miscreants.
  - d) One of them came forward and gave hand signal to stop my car.
  - e) Accordingly I slowed down thinking they might be requiring a lift.
  - f) However when my car reached within a few feet from the boy I noticed that he was holding a Khukri in his hand.
  - g) I realised the impending danger and immediately accelerated my car.
  - h) The other two boys shouted in a language (not manipur language) and threw a stone which hit my car at the back causing superficial scratch to the vehicle.
  - i) Thereafter I drove fast and stopped at the army barrier post near Kanto village and narrated about the incident to the Guard personal to further report to his higher authority.
- 4. It appears that the incident is related to the unfortunate incidents of rivalry between Kuki and Meitei communities. At present the URC is being visited by mostly Meitei Community whereas the surrounding area near Koubru Dwar is populated by Kuki personal, some of whom look for opportunity to cause harm to the visitor of URC.
- 5. You are therefore requested to look into the matter and take necessary action to prevent any reoccurrence of such incident.
- 6. After reaching my home I telephonically reported the matter to Adm comdt. Leimakhong Mil Stn.
