



- 1.G.I. Pipe set (2) [12 x2 =24],value= Rs. 24,000/-
- 2.Computer monitor (4 nos.),value= Rs. 48,000/-
- 3.Computer C.P.U (1 nos.) , value =Rs. 65,000/-
- 4.Printer (1 nos) value= Rs. 55,000/-
- 5.Wheel chair (3 nos), value= Rs. 33,000/-
- 6.AC (1 nos) , value = Rs.40,000/-
7. Tiles 20 packages, Value = Rs.50,000/-
8. Iron plate (3 nos), Value = Rs.30,000/-
9. Post Angle Value = 50,000/-
- Total Value = Rs 3,95,000/-


I could not report the incident in time as we were conducting enquiry of the loss materials and also to the prevailing situation however we could not identified the culprits.
