



Sir,

I have the honour to report that on 3/5/2023 at around 6:30 pm my vehicle Tata truck (Trailer) bearing regd no. NL01AC-8731 was confined at Motbung Bazar along NH-2 while transporting goods items i.e. TMT Bar (i) 8mm-8.920 Ton (ii) 10mm – 9 ton (iii) 12mm-8 ton (iv) 16mm-8 ton from Kolkata due to unruly mob suspected to be kuki youths. As such my driver was escape from the spot by leaving my vehicle at the same place. However, on 9/5/2023 at around 4:30 PM, it came to light that all the goods items were looted by unknown persons suspected to be kuki rioters from my vehicle. The value of my looted goods items is Rs 21,49,606/-(Twenty one Lakhs forty nine thousand six hundred and six). Regarding the matter I couldn't report to the concerned Police Station i.e. Gamnom Sapermeina Police Station till date due to present situation in the state. Hence, I therefore reported to your good office for procedure.


It is therefore, requested to kindly take up necessary legal action at the earliest.
