



Sir,

I, the undersigned have the honour to report that, on dated 28-05-2023, at around 10:30 AM, a group of unknown miscreants from Meitei community, suspected to be members of Arambai Tenngol, Kangleipak Kanba Lup and Meetei Leepun numbering more than 1000 (One Thousand) people holding deadly and sophisticated weapons attacked at my residence and my School i.e. Smartstalk School at Kangchup Patjang, Smartstalk Veng. I along with my family had escaped and the miscreants then looted my properties and finally burnt down all my house hold properties and School building into ashes containing Furniture items, Clothing, Important documents of School and house, Kitchen appliances, Electronic gadgets and others. The total amount of property looted and burnt down by the miscreants is estimated to be around 1,00,00,000/- (One crore only).

Therefore, I request you to lodge an FIR in connection with this incident and take appropriate action against the miscreants at the earliest.


