I, the undersigned have the honour to report that, on dated 28-05-2023, at around 11:00 AM, a group of unknown miscreants from Meitei community, suspected to be members of Arambai Tenngol, Kangleipak Kanba Lup and Meetei Leepun numbering more than 500 (Five hundred)people holding deadly weapons attacked at my residence at Kangchup Patjang, Smartstalk Veng. I along with my family had escaped from our house in fear of them and the miscreants then looted my properties and finally burnt down all my house hold properties into ashes containing Studio materials and Sound systems, Furniture items, Clothing, Important documents, Kitchen appliances, Electronic gadgets and others. The total amount of property looted and burnt down by the miscreants is estimated to be around 70,00,000/- (Seventy Lakhs only).

Therefore, I request you to lodge an FIR in connection with this incident. Thanking you Sir.
