

Sir,

I have the honour to state that today i.e. 24/02/2024 at about 12:30 am, a Mobile Vehicle Check Post (MVCP) was conducted by a combined team led by Shri Laishram Santos, MPS, SDPO-Imphal along with teams of CDO-IW led by myself and assisted by SI. L. James Suresh, a column of 4 Assam Rifles and 216 Battalion CRPF and Inspector Guikan Thangal, OC-City-PS under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW, at Keishampat Junction near Traffic Point. During that one Maruti Wagon-R Car red in colour bearing registration number WB069042 coming from Nityaipat Chuthek side towards our frisking zone was detained for spot checking. On spot checking said car, 1 (one) driver along with 2 (two) occupants who later identified themselves as :-

- (i) Naorem Inaotomba Singh (52 yrs) S/o. N. Ashok Singh of Thinungei Awang Leikai, BPR District.
- (ii) Wahengbam Inaocha (47 yrs) @ Iriba Meitei S/o. W. Irabot Singh of Nambol Khathong Makha Leikai, BPR District and
- (iii) Wahengbam Homendro Singh (28 yrs) @ Naoton S/o. (L) W. Shanta Singh of Nambol Khathong Makha Leikai, BPR District were found.

On further checking the 2 (two) occupants they were found possessing 2 (two) numbers of SLR Rifles bearing body numbers 18059983 and 16752470 along with 2 (two) magazines loaded with 20 (twenty) rounds each respectively. On further spot body searched of (i) Naorem Inaotomba Singh, one Redmi 9A mobile handset along with one JIO SIM card bearing phone number 9863453791, (ii) Wahengbam Inaocha @ Iriba Meitei, one OPPO A57 along with 2 (two) Airtel SIM cards bearing phone numbers 9362263044 and 9362332708 and (iii) Wahengbam Homendro Singh @ Naoton, one iPhone along with one Airtel SIM card bearing phone number 9362805046 as disclosed by them were recovered respectively from their possessions. Hence, they were arrested at the spot at 01:00 am, 01:05 am and 01:10 am respectively and seized the above mentioned recovered mobile handset along with the Maruti Wagon-R Car red in colour from the possession of Naorem Inaotomba Singh at 01:15 am, 1 (one) number of SLR Rifles bearing body number 18059983 along with one magazine loaded with 20 (twenty) rounds and above recovered mobile handset were seized at 01:20 am from the possession of Wahengbam Inaocha @ Iriba Meitei and (iii) 1 (one) number of SLR Rifles bearing body number 16752470 along with one magazine loaded with 20 (twenty) rounds and above recovered mobile handset were seized at 01:25 am from the possession of Wahengbam Homendro Singh @ Naoton by observing formalities.

It is, therefore, the above arrested persons and seized articles were handed over to you for taking further necessary legal action against them.
