Subject :- Urgent request for FIR Filing-Forceful occupation of my house at Minuthong, Imphal by three(3) Meitei families.

Sir,

I have the honour to report that our family had left our house at Minuthong, Ragailong Road, Near Ex-Serviceman Transit Camp, Imphal, Manipur on 19th June 2023, because of the ethnic violence between Zo-Kuki and Meitei communities. I received a telephone call on 20/01/2024 informing me that 3 Meitei families forcefully occupied by breaking the gate and doors.

The total area of the house is 100 feet in length and 60 feet in breadth. The house has two storey building and the estimated cost of the building is about Rs. 20 Crore at present rate and the properties inside the House is worth about 4,180,000 (Forty One lakhs & Eighty Thousand).

The intruders not only forcefully occupied the house but also stole all the properties inside. Additionally, they used harsh words and threatened to burn down the House.

It is therefore to request you kindly to file an FIR on the reason stated above and a copy of the FIR may kindly be forwarded to the Porompat Police Station, Imphal East, Manipur for taking further action.
