Today i.e. 07/04/2024 at 4.30 pm received a reliable information about the presence of some armed miscreants in the general area of Uchiwa Village for committing pre-judicial activities. Acting on the information, a combined team of District Police, Imphal West led by SDPO-MI under the overall Supervision of SP, Imphal West District consisting 2 teams of MIPS including Women Police led by myself, 3 teams of CDO-IW(Papa-47, Mike 57 and Papa 60) and teams of 33 AR COB Lilong led by the Post commander conducted Cordon And Search Operation (CASO) from 5.30 am to 8.30 am at Uchiwa village and its adjoining areas including Imphal river banks, fish farms and paddy fields. During the search operation, the following items i.e 1) Two nos. of SBBL guns, 2) Four nos. of .36 HE Hand grenade, 3) Two Nos. of Tube launchers, 4) Two nos. of Kenwood Handsets, 5) One 9 mm Pistol (Countrymade) with one Magazine, 6) Five nos. of 7.62 SLR ammunition, 7) Twenty one nos. of .303 Rifle ammunition, 8) Twenty four nos. of .38 Revolver ammunition, 9) One Charger guard, 10) One black colour carry bag and 11) One white colour cloth suspected to be bed sheet were recovered from Uchiwa Lamhang Thambalhoubi area at the fish farm of Kamei Abersing suspected to be abandoned by the unknown armed miscreants. The above items were seized at 6.20 am by observing necessary formalities.

On further search of the nearby areas, the following items i.e 1) One SLR Rifle bearing No 15310179 along with one magazine, 2) One Carbine bearing No 15227679 along with one Magazine, 3) One Green colour gunny bag, 4) One Jacket shirt having mixed colour of blue, black and grey were also recovered from Uchiwa Lamhang Thambalhoubi area near the fish farm of Rk. Biren. The above items were also seized on the same day at 6.45 am by observing necessary formalities. A total of 30 fish farms and 15 farm houses were thoroughly searched and around 150 persons were verified. However, no members of the unknown armed miscreants were found at the locality. The seized items are likely to be used for extortion/kidnapping/assassination to disturb peaceful conduct of Lok Sabha Election, 2024, create law and order problems and derail the government machinery.

It is, therefore, considered to register a case under FIR No 10(4)2024 MIPS U/s 400 IPC ,25(1-C) A. Act , 6(1-A) IWT Act & 5 Explosive Substance Act for investigation against the unknown armed miscreants.
