

Sir,

With due respect, I have the honour to report that today i.e 26<sup>th</sup> Feb., 2024 at @ 03.00 PM received information from the Post Master, Imphal Head Post office, that one person namely Borish Singh Khundrakpam S/O Khundrakpam Sarat Singh of Yairipok Bamon Leikai Mathak P.O & P.S - Yairipok, Thoubal District was detained by the post office official's with the assistance of police personal deployed at Imphal Head Post office at the booking counter of Imphal Head Post office while he was trying to send 2(two) parcels suspected to have contained Ganja to one Ningthoujam Newton, 9t A Cross Rd, Viveknagar, Furher Extension, Goeda Muniswamy Garden, Viveka Nagar, Bengaluru-560047. The source report was reduced in writing and submitted a copy to Superintendent of Police, Imphal West District. Thereafter, under the supervision of Superintendent of Police, Imphal West I along with the police team of Imphal PS rushed immediately at Imphal Head Post office. Accordingly, Shri L. Santosh Singh, MPS SDPO Imphal was informed about the matter and he also arrived at the spot around 03:30 PM. On arrival at the Imphal Head Post office, the said person was found detained by the post office official's with the assistance of police personal deployed at Imphal Head Post. On examination he admitted that the 2(two) parcels suspected to have contained Ganja was belong to him and he came at the post office to send the same to one Ningthoujam Newton, 9t A Cross Rd, Viveknagar, Furher Extension, Goeda Muniswamy Garden, Viveka Nagar, Bengaluru-560047. On checking the 2 parcel box in presence of the gazetted officer Shri L. Santosh Singh, MPS SDPO Imphal found 5(five) nos. of plastic packet suspected to have contained Ganja. The recovered 5(five) nos. of plastic packet containing suspected to have contained Ganja were properly weighed by using a weighing machine in presence of independent witnesses along with the gazetted officer Shri L. Santosh Singh, MPS SDPO Imphal. The weight of 5(five) nos. of plastic packet





suspected to have contained Ganja is 540 gm approximately without the weight of the parcel box. The recovered item is listed under the ND & PS act. So, the recovered 5(five) nos. of plastic packet suspected to have contained Ganja and one mobile phone Redmi Note 8 pro having phone No. 8787848445 were seized on production by Borish Singh Khundrakpam S/O Khundrakpam Sarat Singh of Yairipok Bamon Leikai Mathak PO & P.S- Yairipok, Thoubal District in presence of the independent witnesses namely Md. Ali Khan (49 yrs) S/O (L) Md. Abdullah of Kiyamgei Makha Leikai, MTS Imphal Head Post office and Lukram Raghmani Singh S/O (L) L. Gourachand Singh of Thoubal Ningombam Thongju Leikai, Thoubal District, Post Master, Imphal Head Post office by preparing a weighing and seizure memo at 04.10 PM. And he was also arrested from the spot at 04.20 PM. So, the arrested person along with the seized items are handed over to you for further necessary legal action.
