Respected Sir,

I and my family are the residents of the above address for the past 8 years. On 5th May 2023, due to the unfortunate occurrence of ethnic violence against the Kukis by the majority Meiteis, my home in the above address which was a pucca building costing Rs.15,00,000/-, which has been badly damaged, looted and vandalized leaving behind a trail of unimaginable destruction. Because of the violence I and my family fled to Shillong.

My house was targeted by the Meiteis because we belong to the Kuki tribe. My husband is a business man due to this incident he had lost all his business and now as a family we are homeless as well as left with no finances for our daily living. The incident has caused us terrible losses financially and we are suffering from mental trauma.

The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 32,00,000/- (Thirty two lakhs).

Due to lack of legal knowledge and some personnel problems I could not report in time.
