

Subject: First Information Report on the crimes of looting, vandalism and discrimination of Scheduled Tribes

Dear Sir,

With reference to the above cited subject, I have the honour to file to you my First Information Report, in connection with the crimes committed against us which I do as follows:

That, I am Scheduled Tribe belonging to the category of any Kuki tribe, a recognized Scheduled Tribe under the Constitution of India. And I was a resident of Jail Compound (near Old Lambulane), P.O. & P.S., Imphal, Imphal West District, Manipur.

That, on the 8th May, 2023 at about 9:00am a huge contingent of Armed radical Meitei/Meitei's suspected to be members of the Arambai Tenggol and Meitei Leepun attacked our locality. They were picking their targets (those belonging to the Kuki-Zo communities) amongst the residents of the jail compound. And, in the process though a personnel in uniform myself, I alongwith my family, somehow managed to fled to save our lives under the compelling circumstances. Just outside the jail compound we boarded an army truck which took us to an Army Camp in Mantripukhri, Imphal, from where we were evacuated to Churachandpur at about 4:00pm on the same day.

That, it may be reported here that the mob/miscreants were shouting slogans like- 'KANGLEIPAK YAIPHARE', 'KUKI HATLO; HAO HATLO', etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of Shri. N. Biren Singh, the CM of Manipur and the titular king of Manipur who is presently the Rajya Sabha Member from Manipur as the perpetrators openly said that nobody can stop us even the police because the aboved-named persons are patrinizing us and assured us that no harm could be done to us.

4. That, after reaching Churachandpur on the 8th of May, 2023, we took a rented house at V. Munhoih Village, where we continue to settle till date.
5. That, on the 27th September, 2023, at around 2:00pm we got a report from very reliable sources that the Meitei Miscreants had attacked our locality again and had looted, vandalized and burnt all our belongings. They were said to have not spared even our dustbins.
6. That, it may also be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be Rs.15,90,000/- (Rupees Rupees Fifteen Lakhs Ninety Thousand) only. Description of properties looted/ destroyed/ burnt, etc are given in SCHEDULE hereunder.
7. That, I am filing this information lately because of ignorance of the importance of filing FIRs in such conditions and we had gone to the interior villages in Singngat Sub-Division. We have now returned and were informed to necessarily file an FIR. As we have now settled at a rented house in V. Munhoih Village, Churachandpur, Manipur we are in a position to file the said FIR. Thus, I am filing the report today with a prayer to kindly accept our report though filed very lately.

In the given circumstances, I humbly pray you to kindly register an FIR/ ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
